Tax Deductible Voluntary Contributions

Our School Council is proud of the excellent quality of our facilities and resources available for our students. We offer to cater for students' needs and interests. However, these do not come without some extra costs involved.

Each year Kensington Primary School parents show positive support for the school through <u>tax deductible</u> Voluntary Contributions such as the Building Fund and the Library Fund.

Building Fund

Since 2015, financial support has led to considerable improvements being carried out across our school campus. Money from the Building Fund has allowed us to accomplish the following:

- Supply and install cooling and heating split systems in all classrooms
- Insulation was put in the roof cavity to enhance the energy efficiency of the split systems
- As part of the Cooling Project, block out blinds were also installed in all classrooms and in other rooms of the school
- Four heating and cooling split systems were recently installed in the library
- Completion of the Gym. Installation of suspended ceiling and extra panelling mounted on the walls
- Recarpeting and painting in all classrooms
- Partly funded the operable walls above the library in the Year 3 teaching space
- Modernisation of areas to be more functional for example, a teacher office in the Year 3 area is now a locker area for students
- Paid for repairs to eight external concrete windowsills damaged by concrete cancer
- Repairs, painting, plumbing and general maintenance
- The removal of walls in a storeroom to create a student support area
- Replaced entrance doors in library
- Replaced entrance doors above the library
- Replaced lino in the BER Foyer
- Carpeted Teaching carpeted
- Replaced all windows in the library and classrooms above the library
- Purchased and installed split systems for the gym foyer, music room and art room
- Acoustic panelling in the gym

Library Fund

Financial Support for Families

Kensington Primary School understands that some families may experience financial difficulty and offers a range of support options, including:

- State Schools' Relief provides financial support for eligible families to purchase clothing/uniforms at a reduced rate
- Camps, Sports and Excursions Fund (CSEF) provides payments for eligible students to attend camps, sports, and excursions
- 2025 only School Saving Bonus (SSB). The School Saving Bonus provides a one-off \$400 to help Victorian
 families cover the costs of their child/children's school uniforms, excursions and activities.
 Families can choose how they spend the School Saving Bonus. It can be used towards 2025 school costs,
 which may include:
 - > camps, trips, excursions and incursions
 - swimming and sporting programs
 - > outdoor education programs
 - > graduations
 - > school uniforms
 - cooking & gardening

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:



Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
